- **Self-attested ITD PAN Card of the publisher.**

- **List of Authorized Distributor (if any) in J&K.**

Catalogues submitted without the above documents shall not be considered for selection by the UT Level Library Advisory Cum Purchase Committee (UTLLACPC).

The Titles/books shall have to be supplied on the graded rate of discount fixed by the Raja Rammohun Roy Library Foundation (RRRLF) indicated hereunder:

01 to 10 copies of a title	10% discount
11 to 25 copies of a title	15% discount
26 to 100 copies of a title	20% discount
101 to 200 copies of a title	25% discount
201 – 500 copies for a title	30% discount
501 - & above	35% discount

- Preference shall be given to the books having ISBN number.
- The printed price mentioned in the catalogues/broachers/jackets shall be accepted as correct price and shall remain valid for **One Year from the date of submission.**
- Books without printed price and books whose price have been altered by pasting slip or rubber stamp will not be entertained. No claim for increased price shall be entertained after the selection.
- The supply order shall be placed in the name of the publisher of the approved title (s). Such publisher (s), however, may also supply the approved title through an already existing authorized distributor in case the publisher / firm is not able to supply itself, the authorization shall be duly signed and stamped.

Publishers of the selected titles shall have to make the supply within 15 days of the placement of orders F.O.R. to the address as may be specified in the supply order.
