1. To assist and complement the efforts of Raja Rammohan Roy Library Foundation (RRRLF) to achieve its mission objectives.
2. To make judicious selection/purchase of books under Raja Rammohan Roy Library Foundation (RRRLF) or undertake any other infrastructural requirement covered under scheme, after following due procedure.
3. To allocate Budgetary provision for the implementation of matching and non-matching schemes, administered by Raja Rammohan Roy Library Foundation (RRRLF).
4. To consider the cases of non-governmental organizations or any other eligible private bodies for their recommendation to Raja Rammohan Roy Library Foundation (RRRLF) on the basis of prior inspection by Director, Libraries and Research, J&K.
5. To approve the programmes for seminars/workshops/trainings under matching and non-matching schemes of Raja Rammohan Roy Library Foundation (RRRLF).
6. To discuss, consider and approve any other scheme as shall be incorporated by the Raja Rammohan Roy Library Foundation (RRRLF) from time to time.
7. The Committee shall also finalize the lists of books to be purchased from local authors, or those not covered under RRRLF Scheme.


